

Matrix structure provided to support multiple copies of transcribed content. Single-copy rates would be combination of Transcription or Graphics Mastering and their respective single-unit Production rate (for one unit/copy).

Complexity is assigned to a complete project (Title, Test, etc.)

Simple	Content contains concepts and images are straight forward, requiring minimal descriptive work. This category includes most literary topics and primary education (K-6) titles.
Medium	Content contains Secondary education (7-12) STEM and Business titles. Nemeth code will be used as necessary. Depending upon the sophistication of the target audience the majority of Social Sciences titles will also be considered a medium complexity rating.
Complex	Advanced topic content. Most Higher Education STEM and Business titles will fall into this category. Nemeth code will be used as necessary.
Specialty	Specialized titles include medical and others, where very specific domain expertise is required. Nemeth code will be used as necessary.

Based upon availability: projects needed within less than 30 days may carry an expedite fee, not to exceed 35%. The actual expedite fee will be determined on a case-by-case basis. Capacity/workload, complexity of the job, and the timeline will be factored in before a mutually agreed upon fee will be assessed.

Pricing excludes shipping (if embossing is required). All shipping expense will be billed as pass-through, once mutually agreed upon.

Nominal cycle time for a textbook project is 6-8 weeks.

If the textbook is provided in hardcopy (rather than electronic format), a \$500 flat rate fee will be added for removing bindings and inserts, collating pages, scanning/OCR, and accuracy verification. The processed textbook will be provided in electronic format.

Contractor has disclosed all potential fees. Additional charges will not be accepted.
