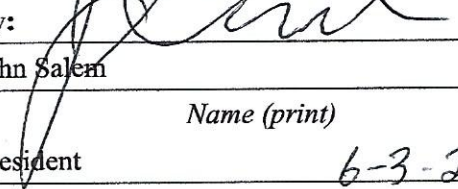
Description of Renewal Notice:

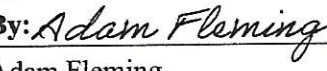

The more students put into productions cost will go down and students can be paid or get hours towards internships. Student interns shall only be used as production assistants and interns as determined by JMU.

Football and Basketball productions: all or most equipment will be JMU. Olympic Sport productions: all or most equipment will be Telemedia Productions.

Camera operators for Digital Video sport productions with Telemedia's Equipment \$271.10 per operator.

Tech Days price to be determined and mutually agreed depending on hours and personnel. Most Tech Days will include the Technical Director (TD), Director, Replay and Graphics, and possible one camera. The length of a Tech Day may vary, but normally is 6-8 hours.

Day Trip for sports and/or overnight: To be determined and mutually agreed on a per event basis.

2. Event Cancellation will be as follows:

In the event that a production event agreement is cancelled due to ESPN selecting a game for national distribution during the 12-day or wild card selection windows, JMU will compensate contractor at a rate of 30% of the full production rate (i.e. not preseason). This cancellation fee does not apply to any other cancellation due to natural events for other undisclosed reasons. For all other events it would be as follows:

- Day before 25% of the contracted rate.
- Day of event 50% of the contracted rate.

3. ALL MadiZONE footage is the sole property of JMU Athletics and any distribution of footage can only be done with written approval by JMU Athletics. Telemedia Productions, Inc shall not share or send ANY footage to any individual, institution or media outlet unless directly requested from JMU Athletics.

4. There shall be no additional miscellaneous or incidental fees that have not been identified herein.

5. Payment Terms – As an agency of the Commonwealth of Virginia, James Madison University makes payment in accordance with the *Code of Virginia*, §2.2-4347 through 2.2-4354, Prompt Payment.

6. Contractor agrees that all exceptions taken within their initial response to RFP #ASF-1176 that are not specifically addressed within this negotiation are null and void.
7. Contractor has disclosed all potential fees. Additional charges will not be accepted without mutual written agreement between parties, e.g., contract modification and/or change order.
