Filming that requires 3 or more consecutive days, JMU will then be charged our weekly rate. A week of consecutive days cannot exceed 6 days in a row.

*** Additional rental needs that are not available in house are at market prices and will vary from project to project based on the overall needs to complete the project as requested.

* Video capture on location and in studio for a crew of up to 3 persons is \$130/hr. In some limited cases, a single crew member (director/camera operator) may be all that is required which is \$100/hr. Pricing for projects that require more than a 3 person crew that may include a director, director of photography, camera operator(s), audio engineer, grip, and production assistance(s), a custom quote outlining all needs for video capture and crew size shall be submitted to JMU for approval prior to final agreement to the work order.
