
Description of Renewal Notice:

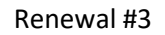

5. Top Gun Auto has the capability to perform aluminum body repair, with a labor rate of \$66.63/hour.
6. Top Gun Auto shall agree to the annual increase amount to be based on the CPI-W scale per renewal.
