2. LabCorp Employer Services and James Madison University agree upon the thirty (30) recipient minimum as outlined in the original proposal submitted by LabCorp Employer Services.
3. LabCorp Employer Services has confirmed that there shall be no additional miscellaneous or incidental fees that have not been identified in the original proposal submitted by LabCorp Employer Services. There are no hidden charges, normal contract exclusions apply.

4. LabCorp Employer Services has confirmed that they will provide at least 2 registration coordinators each day of any flu clinic, including 2-day flu clinics.
5. James Madison University understands that LabCorp Employer Services is unable to accept payment onsite. In this case, LabCorp Employer Services agrees to provide vaccinations for insured recipients only. JMU will not be responsible for any billing related to uninsured recipients.
6. As an agency of the Commonwealth of Virginia, James Madison University makes payment(s) in accordance with the Code of Virginia, §2.2-4347 through 2.2-4354, Prompt Payment.
